# BADGERS MOUNT

COMMUNITY NEWSLETTER FOR THE PARISH

Goodbye Winter, hello Spring! Badgers Mount is afresh with new green leaves and bobbing heads of little white flowers in the woods and verges. The last 2 years have been hard for the Community, coming out of Covid, but it is time to step into spring with hope and optimism. We are not out of the woods yet, with the impending energy crisis, sharp increase in cost of living & the looming climate change challenge. Despite this, ours is one of the few Parishes in the Sevenoaks District Council where the Precept has been reduced by almost 38%. The Parish Council has also appointed a new Clerk, a local resident, to bring focus & deeper understanding of the issues facing the Parish. The ongoing Ukraine War has resulted in the Community coming together to help the less fortunate through two fundraising activities: a Bake Sale and a Books & Toy Sale. Both of these have been very successful and shown us what a wonderful & generous community we live in. We now look forward to celebrating Easter this month & the Queens Platinum Jubilee celebrations in June.

## PLANNING UPDATES

The Parish Council is consulted on all planning applications for extensions to existing properties and new buildings and submits comments to Sevenoaks District Council (SDC) including, where appropriate, residents' comments. Recent decisions which are outside Badgers Mount but which affect us include: -

**Broke Hill Golf Club** – Following the refusal of the application by SDC, the applicant submitted an appeal to the Planning Inspectorate who recently dismissed the appeal.

**Chevening House** – SDC refused the application for major earthworks to change the landscape of the southeast area of the site which would have meant up to 200 two way lorry movements per day at peak times of the work for over five years passing along the Orpington Bypass. The applicant has just submitted an appeal to the Planning Inspectorate which will be held at a public enquiry. The date of the hearing will be advised in due course.

**Land off Wheatsheaf Hill** – Activities on the site continue to be monitored by Bromley Council enforcement officers as injunctions to stop work and not put mobile homes or fences on the site have been ignored.

**Skip site near Polhill roundabout**– Following the refusal of the Lawful Development Certificate for the site by SDC, the applicant appealed to the Planning Inspectorate. The appeal has just been dismissed.

## NEIGHBOURHOOD PLAN UPDATE

The Neighbourhood Plan (NP) is temporarily paused pending revision of the delayed Sevenoaks District Local Plan. The current situation of our NP is as follows:

- 4 initial working groups were set up and have reported. These groups covered Housing and Development; Character and Heritage; Environment and Local Economy; and Infrastructure and Community Assets.
- Following discussion with our Planning Consultants, we have produced an initial draft outline NP. This contains a brief description and history of our community, followed by an initial set of Draft Policies or Visions. Each Policy contains one or more broad aims identified by the Working Groups; these aims allow us to identify specific action proposals for the community to take forward.
- The primary Policies identified to date are:
  - Climate Change – this is a central government initiative
  - Community Woodland – improved access and management
  - Community Greenspace – allocate a modest area of land for green/play/exercise
  - High Quality design of housing – maintain the ‘look’ of our community in the form of a Village Design Statement
  - Green Infrastructure and Biodiversity – establish and maintain a network of green infrastructure and habitat corridors
  - Connectivity and Road Safety – improve the existing Rights of Way and facilitate safe walking & cycling
  - Developer Contributions – links to the previous Policy in order to identify contributions for measures such as traffic calming and improving the pedestrian/cycling network
- These Policies form an outline which is anticipated to remain unchanged for several decades; specific proposals will be raised under the various policies for concrete changes. Based on initial community discussions, several possible proposals have been identified:
  - Pedestrian crossings
  - Provide a central village play area
  - Electric charging points
  - Signposted walks
  - Traffic calming
  - Bicycle trails
  - Improved Telecomms/Broadband
  - Improved bus services
- The Parish Council is currently trying to make progress on the first 2 of these (Pedestrian crossings and a central play area). Progress depends on gaining approval from the relevant owners/authorities and on amassing the required funding.

Residents are always welcome at our Parish Council meetings. Meetings are held on the 1st and 3rd (if required) Thursdays of each month in the Memorial Hall and Agendas are published on our website and notice boards so that you know what is going to be discussed.

We welcome all suggestions and feedback and we'd really like you to let us know if there is something that needs repairing (street lamps, kerbs etc), your comments on neighbouring planning applications or anything that you have comments/concerns about in our community. ### Speed reminder on unadopted roads

A reminder that the speed limit on Highland/Badgers Road and Milton/Johnsons Avenue is 20 mph. These roads are narrow, have blind bends and have no pavements for pedestrians to use.

### DOG FOULING

There are still some dog owners who do not clear up after their dogs. There have been recent complaints about dog mess on footpaths and even on other people's drives. There are 5 red dog waste bins around Badgers Mount, and Sevenoaks District Council has also advised that it is permissible to put dog waste bags in the 3 black litter bins along Old London Road, but please don't put general litter in the much smaller red dog waste bins. Dog faeces are sometimes seen on the ground near the dog waste bins, left by owners who are too lazy to bag and bin it! Remember that the person in charge of a dog can be fined £1,000 under the Dog Fouling Act (2016) for not clearing up responsibly.



### IDENTIFICATION TAGS FOR DOGS

It is a legal requirement that all dogs are microchipped, and the details must be kept up to date. The Government are set to introduce new rules saying that cats must be microchipped by the time they are 20 weeks old. Failure to update details could result in a £500 fine.

### CONTROL OF DOGS

Under the Control of Dogs Order 1992, all dogs in public places must have a collar and identification tag. You can be fined £5,000 for failing to comply with this requirement. Also remember that if a dog is worrying livestock, the farmer is entitled to shoot the dog, so keep it on a lead whenever you are near fields. There is no second chance option!



## BADGERS MOUNT FOR UKRAINE-BAKE SALE + BOOKS & TOYS SALE FUNDRAISER

On Sunday March 13th, 2022, the Badgers Mount Parish Council and the Badgers Mount Residents Association organised a Bake Sale Fundraiser at the Badgers Mount Memorial Hall to help raise money to support the Ukraine Crisis. The whole community got baking to get behind the cause to send money to **DEC Ukraine Humanitarian Appeal, British Red Cross**. It was very heart-warming to see the number of cakes donated by the residents – they looked amazing and were scrumptious. Fabulous contributions from local businesses came from Nesbit House, JJ Cakes, Polhill Garden Centre, Bojangles Café, Waitrose & Tesco were gratefully received. Approximately 150-200 visitors walked in and enjoyed the delicious cakes, served with tea & coffee by a team of amazing volunteers from the Community. The event raised £1585 (matched by the BMRA & Barclays resulted in a total of £3585 contribution, and the Community could not have been more pleased with the outcome.

On Sunday April 3rd, 2022, a books & toys sale was organized towards the same cause raising another £700. A great example of what can be achieved if a whole community comes together to help others who are having to endure unspeakable hardships. Our heartfelt thanks to all those who came to support the fundraiser!

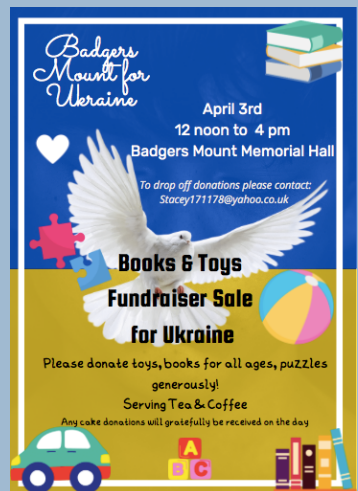


## FOOD BANK

## LONDON ULTRA LOW EMISSION ZONE (ULEZ)

The Mayor of London Sadiq Khan is proposing to extend the ULEZ, which is currently only inside the North and South Circular roads, to cover all the London Boroughs in 2023. It would have a significant effect on everyone in this area who does not have a compliant vehicle (most cars made after 2015 are likely to be compliant as are some earlier models, please check gov.uk) who will be charged £12.50 per day for cars to:

- Go to the doctors, dentists or chemists in Orpington, Chelsfield or Green Street Green.
- Go to hospital at Orpington or Locksbottom.
- Go shopping in Orpington or Bromley.
- Get fuel at Pratts Bottom.

The present system is enforced by ANPR cameras a short distance inside the boundary. However, if enforced by a system which detects the moment you cross the boundary it would mean that you would be charged to:

- Drop off or pick up anyone from the ticket office at Knockholt Station (Sevenoaks Road passing the station is in Kent but road into the station is in the London Borough of Bromley).
- Travel round Hewitts Roundabout to get onto or leave the M25 as the whole of the roundabout is in Bromley.
